# CITY OF CORYDON CITY COUNCIL REGULAR MEETING MINTUES WEDNESDAY, AUGUST 27, 2025 5:30 P.M.

#### 1. Call to Order/Roll Call

Mayor Pro-tem Dawn Christian called the meeting to order at 5:30pm. Councilors present: Dawn Christian, Chase Clark, Kyle Hampton, Kenny Holmes, and Bryan Wolfe. Absent: Nathan Bennett. Others present: Jared Chambers, City; Stacy Gibbs, City; Tierra Shield, Lily's Sports Bar; and Teresa Evans, TR.

#### 2. Approval of Agenda

Motion to approve the agenda made by Hampton. Seconded by Holmes. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: None. Motion carried.

- 3. Consideration/Approval of Alley Closure at Lily's Sports Bar for Grand Opening Tierra Shields informed council that the bar plans to have a grand opening on September 06, 2025 with outdoor entertainment. They asked if the alley could be closed between the bar and Franklin street for the event. Motion to approve the alley closure for September 06, 2025 made by Holmes. Seconded by Wolfe. - 7. Discussion of City Procedures and Progress Nathan joined
  - a. City Clerk Report: Gibbs reported that the office will start morning to the new accounting/billing system, Civic Systems; the pool's last open weekend this weekend; reminder of Beggar's Night set for the Saturday of or prior to October 31 this year is October 25<sup>th</sup>; we still need a new P&Z member (Eric Jaeckel resigned in Nov 2024); and a 3-member committee for South Street Rehab project has been put together and will have their first meeting in late September.
  - b. Public Works Report Chambers reported on the Marion/Dekalb street intersection repair we needed more time for it to cure appropriately; he met with Kading representatives regarding repairs needed on Oak Street. They identified 42 of 164 panels that have cracking/breaks (25%); Kading will get new repair plan to council for approval.
  - c. Fire Chief Report Chief not present
- 8. Consideration/Approval of Resolution 2026-006 Approving Transfer of Funds Motion to approve Resolution 2025-006 made by Wolfe. Seconded by Clark. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: None. Motion carried.
- 9. Consideration/Approval of Bids for Asbestos Abatement at 313 N Johnson Street and 409 E Jackson Street Motion to approve the low bid of \$3600.00 for both properties from Dan Laursen made by Holmes. Seconded by Wolfe. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: None. Motion carried.
- 10. Consideration/Approval of Storm Sewer Repair/Relining Project Costs

Chambers reported that several months ago the IDOT notified him of possible undermining at a storm sewer on Hwy 2. This is part of the city's maintenance and responsibility. Subsurface is a company currently working with Wayne County on relining projects. After meeting with Chambers, they provided a bid to reline the storm sewer which will repair the cracked tube, but there will need to be more repairs made where undermining has occurred. The quote from Subsurface includes traffic control for the repairs. Chambers is meeting with our regional IDOT engineer the morning on August 28, 2025 to be sure that the IDOT will allow the relining.

Motion by Clark to approve the contract with Subsurface for storm sewer relining pending Chambers getting approval from the IDOT. Seconded by Hampton. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: None. Motion carried.

## 11. Discussion of Ordinance Updates

The council discussed changes and the additions of the following ordinances: livestock, accessory dwelling units, franchise fees, and storm water fees. Gibbs will work on drafts to be reviewed by the council.

## 12. Committee Reports

Nuisance – Property at 400 S. Dekalb is pending sale; the new owner plans to tear down immediately. Parks & Rec – an application was submitted to WCF Seeds for Success for pickleball resurfacing; Nicole Strickland is taking leadership with committee, grant funding for projects, and scheduling winter adult rec activities. Cats – Christian is getting a committee set.
