Gibbs discussed the reimbursement resolution passed for the new fire department pumper truck. These funds may be redirected to the South Street reconstruction project to assist with budget needs.
- b. Public Works Report: Crew member reported on updates to Oak Street repairs; water leaks on Lincoln Street; repairs needed for the trailer vac hose; and a quote for electrical work at the Lagoon/SAGR storage shed.
