CITY COUNCIL REGULAR MEETING MINUTES
WEDNESDAY, JANUARY 14, 2026 5:30 P.M.

1. Call to Order/Roll Call

Mayor Bennett called the meeting to order at 5:30pm. Councilors present: Dawn Christian, Chase Clark, Kyle Hampton, Kenny Holmes, and Bryan Wolfe. Others present: Stacy Gibbs, city clerk; Angela Nickell, Jacob Clark, public works; Josh Cobb, fire chief; and Kenzie Miner, Time Republican.

2. Approval of Agenda

Motion to approve the agenda made by Christian. Seconded by Hampton. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.

3. Open Forum

No comments.

4. Give Audience to Joe Casavecchia Regarding Nuisance at 312 S West Street

Mr. Casavecchia joined the meeting via Teams video conference. He reviewed his plan to address the nuisance at 312 S West Street and requested an extension of time to July 01, 2026 from the council. He will repair the fence around the property immediately. The council agreed to allow him until July 01, 2026 to have the property cleaned up which includes removing all debris from the property, adding clean fill dirt to grade, and capping all utilities. If these issues are not completed by the deadline allowed, the city will initiate next steps to have the nuisance abated.

5. Consideration/Approval of the Consent Agenda

- a. December Receipt Report
- b. Unpaid and Prepaid Bills

Gibbs informed council that reports are still being corrected due to new software (Caselle) implementation. The December Receipt Report has some inaccuracies that need addressed by Caselle. When corrections have been made, the receipt report will be brought back to council for additional approval.

6. Discussion of City Procedures and Progress

- a. City Clerk Report: Gibbs reported on the new software implementation. Things continue to progress well but still have items to correct.
- b. Public Works Report: Clark and Nickell reported on several water leaks repaired over the last week and that the street sweeper repairs should be completed by the end of January.
- c. Fire Chief Report: Cobb reported that the annual fire department dinner will be held on March 21, 2026; the new pumper truck has a few more items to be added to be ready for operation; and that Chad Sheets retired from the department and Mike Thomas has joined as a new member.

7. Consideration/Approval of Resolution 2026-026 Tax Abatement and Minimum Assessment Agreement for Wound Care LLC, Cindy Salsberry

Motion to approve Resolution 2026-026 made by Holmes with the correction of name of applicant to Wound Care, LLC on the abatement application. Seconded by Wolfe. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.

8. Consideration/Approval of Engineering Agreement for 2026 Water System Improvements with Hall Engineering Company in the amount of \$133,800.00
Nancy Buss with Hall Engineering joined the council via Teams video conference. She provided a brief overview of the agreement for several water main improvements. These engineering services can be reimbursed through the State Revolving Fund (SRF) fund received by the city. Buss anticipates that the project could begin in later fall 2026 or early spring 2027.
Motion to approve the agreement with Hall Engineering for 2026 Water System Improvements in the amount of \$133,800.00 made by Christian. Seconded by Hampton. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.
9. Consideration/Approval of Bid for South Street Reconstruction Project Street Core Drilling
Nancy Buss reviewed two quotes received for core drilling services. During previous council discussions, it was determined that phasing the South Street Reconstruction project is necessary due to cost restrictions.
Motion to approve the quote from CMT in the amount of \$6,855.00 made by Wolfe. Seconded by Clark. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.
10. Consideration/Approval of the Appointment of City of Corydon Fire Chief, Josh Cobb, for 2026
The fire department annual election for officers was held in December 2025. The department voted Josh Cobb in as Chief.
Motion to approve the appointment of Josh Cobb as Chief for the Corydon Fire Department made by Hampton. Seconded by Wolfe. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.
11. Consideration/Approval of Representations Letter to City Auditors (RGE, PLC.)
Gibbs reported the FY25 annual auditors exam has been completed. The letter to the auditors acknowledges that they, as a council, are not aware of any significant financial irregularities or have any knowledge of suspected fraud affecting the City.
Motion to approve the representations letter to the city's auditors (RGE, LLC) made by Christian. Seconded by Hampton. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.
12. Consideration/Approval of Purchase of Ductile Iron/Concrete Saw up to \$5000.00
Clark reviewed two quotes received for the purchase of a ductile iron/concrete saw. He explained that the quote from Contractor Solutions is slightly higher by approximately \$33.00 but it has a longer guide bar which will be more useful for the crew.
Motion to approve the purchase of a ductile iron/concrete saw for \$3309.82 from Contractor Solutions made by Holmes. Seconded by Clark. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.
13. Consideration/Approval of Starting Wage for City Crew Hire

The Personnel Committee requested approval to hire an additional city crew position at the starting wage of \$24.00 per hour.

Motion to approve a starting wage of \$24.00 per hour for city crew new hire made by Hampton. Seconded by Wolfe. Ayes: Christian, Clark, Hampton, Holmes, and Wolfe. Nays: none. Motion carried.

14. Committee Reports

Gibbs reported that final nuisance notices have been sent out regarding a derelict property at 415 E Monroe. Wolfe asked if the monthly Housing/Nuisance Committee meeting could be moved to the afternoon. Gibbs will move the meeting to the third Thursday of the month at 2:30pm. Gibbs asked Christian about getting the Cat Committee active. Holmes said he would join this committee. Gibbs will get dates established and contact interested community members.

15. Discussion Good Cause Business

Clark reported that the RFP for a new radio tower has been released. The new tower will be located at the county farm, west of Corydon.
