

# ORDINANCE NO. 364

## AN ORDINANCE AMENDING THE CORYDON CODE OF ORDINANCES OF THE CITY OF CORYDON, IOWA, BY AMENDING CHAPTER 13.08, WATER SERVICE – RATES AND CHARGES

BE IT ENACTED by the City Council of the City of Corydon, Iowa:

**SECTION 1. Purpose.** The purpose of this ordinance is to amend Chapter 12.08.010 of the Corydon Municipal Code to increase the rates and charges for the use of and the service supplied by the municipal water system.

**SECTION 2. Amendment.** Chapter 13.08.010 of the Corydon Municipal Code is hereby amended by deleting the existing section and replacing it with the following:

### 13.08.010 – RATES AND CHARGES ESTABLISHED.

There are established rates and charges for the use of and for the service supplied by the municipal water system of the city, based upon the meter reading of the amount of water consumed as follows:

WATER UTILITY (GALLONS)	CURRENT RATE SINCE 12/20/2017	EFFECTIVE 01/01/2025	EFFECTIVE 07/01/2026	EFFECTIVE 07/01/2027
0 - 2500 (minimum bill)	\$ 30.00	\$ 39.00	\$ 42.90	\$ 45.05
2501 - ABOVE	\$ 7.00	\$ 9.10	\$ 10.01	\$ 10.51


**SECTION 3. Repealer.** All ordinances of parts of ordinances in conflict with the provisions of this ordinance or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 4. Severability Clause.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 5. Effective Date.** This ordinance shall be effective on January 01, 2025, after its final passage, approval and publication as provided by law,


